REQUEST:

Allow a High-Intensity Park consisting of a horse racing facility including concession stands and mobile food vendors on 11.32 acres of land in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.

LOCATION:

The project site is located on the southeast corner of Althea Avenue and Cambria Avenue, approximately 13 miles west of the nearest city limits of the City of Firebaugh (49993 W. Althea Avenue) (Sup. Dist. 1) (APNs 004-130-25, 004-130-26, 004-140-23, 004-140-24, 004-140-25,

004-140-26).

PLANNING COMMISSION ACTION:

At its hearing of April 13, 2017, the Commission considered the Staff Report and testimony (summarized in Exhibit A).

A motion was made by Commissioner Borba and seconded by Commissioner Lawson to adopt the Mitigated Negative Declaration prepared for the project, adopt the required Findings for approval of a Conditional Use Permit, and approve Unclassified Conditional Use Permit No. 3421, subject to the conditions of approval listed in the Staff Report with the inclusion of additional conditions to require security to be contracted with the Fresno County Sheriff's Department or equivalent, and require a large animal veterinarian to be within a 15-minute drive of the park on each event day.

This motion failed on the following vote:

Staff:

The Fresno County Planning Commission considered the Staff Report dated April 13, 2017, and heard a summary presentation by staff.

Applicant:

The Applicant did not concur with the Staff Report. She described the project and offered the following information:

- There is a \$1 million dollar insurance policy that will cover the proposed horse racing events.
- The proposed horse racing events are family oriented; on Halloween I have trick-or-treaters at the ranch.
- The compadres want to get together and they love their animals.
- The history of law enforcement issues with the horse racing events have been a series of misunderstandings.
- Gambling is not allowed at the horse racing events.
- We have a permit to sell beer (and no off-site alcohol is allowed) at events.

Others:

One other individual presented information in support of the application stating that gambling is not allowed at horse racing events, and also asserted that the Applicant would work with the Sheriff's Department to deal with issues such as intoxicated patrons.

Lieutenant John Reynolds with the Fresno County Sheriff's Department spoke in opposition to the application citing a history of arrests and illegal activities suspected to be connected with unpermitted horse racing events hosted at the subject property.
