REQUEST: Allow a mobile home as a permanent second residence on

a 1.38-acre parcel in the AE-20 (Exclusive Agricultural, 20-

acre minimum parcel size) Zone District.

LOCATION: The project site is located on the east side of Kenneth

Avenue between Adams Avenue and Sumner Avenue (7386 S. Kenneth Avenue) (Sup. Dist. 4) (APN 345-050-

18).

## PLANNING COMMISSION ACTION:

At its hearing of March 30, 2017, the Commission considered the Staff Report and testimony (summarized in Exhibit A).

A motion was made by Commissioner Borba and seconded by Chairman Mendes to deny the Appeal of Director Review and Approval No. 4471 and uphold the Director's approval of the subject application.

## **EXHIBIT A**

Appeal of Director's determination to approve Director Review and Approval No. 4471

Staff:

The Fresno County Planning Commission considered the Staff Report dated March 30, 2017, and heard a summary presentation by staff.

Applicant:

The Applicant concurred with the Staff Report and recommended Conditions. He offered the following information to clarify the intended use:

- We have some violations on the property and we are actively trying to correct them; we have removed cars from the property, cleaned up the parcel, and filed this application to correct one of those violations.
- We installed a fence between the proposed mobile home and the neighboring residence.
- The home will be for my grandparents to live in; we have no plans to rent it out.
- Many of the complaints regarding this property were due to the previous property owner.

Others:

No other individuals presented information in opposition to the Appeal. Three individuals spoke in support of the Appeal:

- Approval of the second residence could increase criminal activity at the site.
- Additional residences in this area increase the danger to drivers and pedestrians traveling on Kenneth Avenue and increase the conflicts with the surrounding agricultural activities.
- One individual identified specific concerns relating to the placement of the mobile home and its proximity to the existing residence on an adjacent parcel.

Correspondence:

No letters were presented to the Planning Commission in opposition to the Appeal. Two letters were presented to the Planning Commission in support of the Appeal.
