**ENFORCEMENT OF PAYMENT:** If the taxes remain unpaid after the delinquency date, a tax lien notice will be mailed to the assessee, a tax lien will be recorded against the assessee, and the taxes will be transferred to our Revenue Collections Unit for collection. These actions will increase the amount due by the addition of collection fees and a release of lien fee. The amount due will continue to increase by the addition of a 1.5% penalty, which attaches each month until the taxes are paid in full.
