NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE SANGER UNIFIED SCHOOL DISTRICT GENERAL OBLIGATION BOND MEASURE

NOTICE IS HEREBY GIVEN to all qualified electors in the County of Fresno, California that on Tuesday, November 6, 2018, there will be submitted to the voters the following measure:

To continue improving college/career preparation and reduce overcrowding by constructing the Sanger Unified School District Educational Complex including vocational/career education classrooms/labs; wiring/technology infrastructure, computer, engineering, science labs; emergency communication systems, security door locks, cameras; up-to-date classrooms; shall Sanger Unified School District issue \$70,000,000 in bonds at legal rates, levy on average 6 cents per \$100 of assessed valuation, raising \$4,900,000 annually for issued bonds through maturity, requiring audits, oversight, all money used locally?

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than Monday, August 6, 2018 by 5:00 pm. Paper copies of arguments must be submitted with original signatures, as well as by email at clerk-elections@fresnocountyca.gov in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or argument submitted. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after August 6, 2018 by 5:00 pm.

ALL ARGUMENTS submitted shall be verified in substantially the following form:
