PROGRAM TITLE: Intensive Community Services and Support Team (ICSST) - FSP **PROVIDER:** Turning Point

PROGRAM DESCRIPTION: The Intensive Community Services and Support Team (ICSST) provides outpatient services to a minimum of 90 adults and older adults who have a Serious Mental Illness (SMI) and a high utilization rate of inpatient psychiatric hospitalization mental health services. Through an individualized treatment model the ICSST Program provides an opportunity for its consumers to achieve independence and self-sufficiency in the community. Services at ICSST include intensive case management, psychiatric services, nursing services, therapy services, supportive housing assistance, linkage to community resources, and assistance in working towards financial stability. ICSST is an Assertive Community Treatment Service (ACT) model and the majority of the services are provided in a community setting. ICSST is committed to the “whatever it takes” philosophy of wellness.

(The 23% reduction in LOCUS scores continues to represent overall progress in the ICSST client population in relation to mental health, housing, and at risk areas. The ICSST program continually works toward program and client specific goals in relation to providing independent skills necessary to reflect LOCUS reduction scores.)

Reduction of LOCUS Scores:

Total *PAF LOCUS Score=	383
Total 1st year LOCUS Score=	<u>294</u>
Total LOCUS Reduction=	89 (23%)

PAF is the Partnership Assessment Form given to FSP clients when they are first admitted into the program. The LOCUS provides an objective measure to help determine consumer service needs. It also provides a way to measure consumer progress and treatment outcomes. A higher score indicates a higher level of service need.

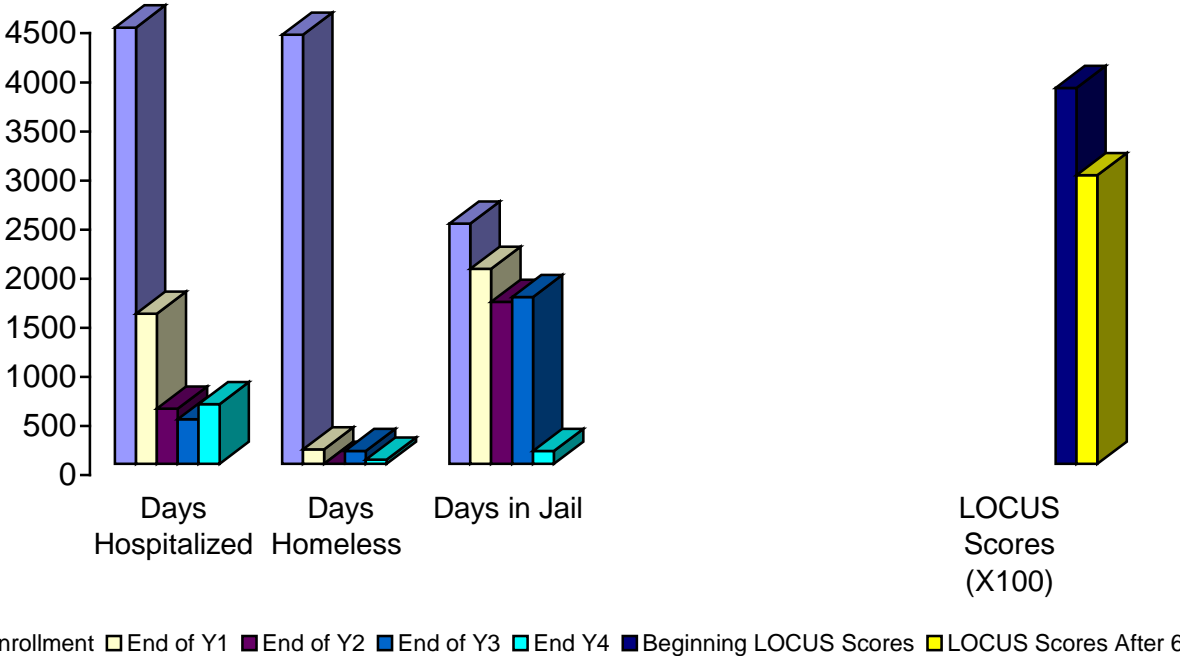
DEPARTMENT RECOMMENDATION(S):
