What businesses are permitted to open on Friday, June 26, 2020 in Fresno County?

The Fresno County Department of Public Health (FCDPH) reviewed business sectors for opening in Variance Counties with approval of the County Health Officer. Fresno County Health Officer has **approved the reopening of Movie Theaters and Family Entertainment Centers and Expanded Personal Care Services** on June 26, 2020. This will require that each business operation fully implement and adhere to [statewide industry guidance to reduce risk](#).

Included below is a list of industries opening including specific coverage and if a submission of attestation to FCDPH will be required to open:
