- If the application is being submitted in person at the <u>Fresno County Clerk's Office</u>, the Sworn Statement must be signed by you in the presence of the <u>County Clerk Staff</u>, and your signature does not have to be acknowledged by a Notary Public. You must also provide valid photo identification to the County Clerk Staff at the time you apply for the copy.

If no record of the marriage is found, the \$17.00 fee will be retained for searching the record (as required by Health & Safety Code Section 103650) and a Certificate of No Public Record, or a letter confirming the existence of a confidential marriage will be issued to the applicant.
