## I. Cov Ncauj Lus Pib

Lub Nroog Fresno raug teeb tsa rau thaum xyoo 1856 thiab hauv ntau lub xyoo xub thawj ntawd, muaj 4,605 leej neeg nyob hauv Lub Nroog no thiab tau siv cov ntaub ntawv xaiv tsa uas siv tes kos rau qhov kev xaiv tsa. Lub Nroog tau pib siv ib daim npav xaiv tsa rau thaum xyoo 1967. Cov neeg pov npav tshaj ntxiv ntawm 200,000 leej rau xyoo 1972 mus txog 300,000 leej rau xyoo 1992. Vim muaj cov neeg pov npav tau tso npe pov npav coob zuj zus thiab tau tsim lwm hom qauv xaiv tsa lawm, Lub Nroog thiaj tau tsim kev hom kev xaiv tsa uas luam daim ntawv pov npav rau cov neeg nyeem rau thaum xyoo 1999. Los txog xyoo 2012, cov neeg tso npe pov npav muaj coob txog 400,000 leej. Thaum txog Lub Ob Hlis 10, 2019, muaj cov neeg pov npav ntau txog 461,008 leej.

Yeej tso cai cia cov neeg pov npav rau daim ntawv pov npav uas raug xa tuaj (VBM) uas raug pib ua los puag thaum xyoo 1962 yog lawv raug raws li cov qauv cai. Hauv xyoo 2002, Lub Xeev tau hloov "tsis pub zam pov npav rau daim xaiv tsa uas xa tuaj lawm" yog li ntawd txhua tus neeg uas xaiv pov npav raws daim ntawv xa tuaj pov npav yuav tsum yog ib tug neeg pov npav raws VBM mus tag ib txhis. Hauv Lub Nroog Fresno, 20% ntawm cov ntawv xaiv tsa raug pov npav raws VBM rau hauv xyoo 1990, thiab cov neeg pov npav no muaj coob zuj zus txog 65% rau thaum qhov kev xaiv tsa Lub Kaum Ib Hlis 2018. Ib qho kev xaiv tsa tshwj xeeb uas ua rau thaum lub xyoo xiab 2019 pom tau tias 86% ntawm cov ntaub ntawv xaiv tsa raug pov npav raws VBM. Yuav tsum ntim cov ntaub ntawv xaiv tsa uas raug xa tuaj pov npav rau hauv ib lub hnab ntawv VBM thiab tus neeg pov npav yuav tsum kos npe rau. Qhov kos npe rau ntawm txhua lub hnab ntawv ntim daim ntawv xaiv tsa VBM yuav raug muab koj los sib piv rau tus neeg pov npav tus qauv tes kos npe thaum tso npe thiab yuav tsum sib thooj ua ntej yuav raug suav.

Hauv xyoo 2016, Senate Bill 450 tau tsim Txoj Cai ntawm Tus Neeg Pov Npav (Voter's Choice Act-VCA). Hauv xyoo 2018, tsib lub nroog raug hloov los siv VCA (Madera, Napa, Nevada, Sacramento thiab San Mateo.) Txoj qauv cai VCA yuav tsum kom txhua tus neeg pov npav tau txais ib daim ntawv xaiv tsa VBM thiab cov chaw pov npav hloov cov chaw pov npav. Hauv ib cheeb tsam lub chaw ua qauv no, thaum Lub Kaum Ib Hlis 2018, Lub Nroog Fresno tau qhib 268 lub chaw pov npav rau ib hnub. Hauv txoj cai VCA, Lub Nroog Fresno muaj tsawg kawg yog 50 lub chaw pov npav thiab qhib 10 lub ntev txog 11 hnub thiab qhib 40 lub ntev txog plaub hnub suav txog cov hnub qab as thiv, cov hnub so thiab Hnub Xaiv Tsa. Ntxiv rau 33 lub chaw tso cov thawv tso daim ntawv xaiv tsa raws li txoj qauv cai VCA uas yuav raug qhib ntev txog 29 hnub suav txog Hnub Xaiv Tsa. Lub Nroog Fresno cov neeg pov npav tuaj yeem xaiv pov npav rau ntawm ib ntawm 50 lub chaw pov npav thiab yuav muaj kev saib xyuas zoo rau sawd daws, suav txog kev tso npe pov npav thiab cov ntaub ntawv xaiv tsa uas xav tau. Muaj tsawg kawg yog 83 lub chaw (50 lub chaw pov npav thiab 33 cov thawv tso ntawv xaiv tsa) rau sawd daws xa cov ntaub ntawv xaiv tsa tuaj. Cov neeg pov npav kuj tuaj yeem xa lawv cov ntaub ntawv xaiv tsa VBM tuaj raws qhov chaw xa ntawv them nqi.

Hauv Lub Yim Hlis 2018, Lub Nroog Fresno tau sau ib Tsab Ntawv Thov kom siv hom kev xaiv tsa tshiab. Yuav tsum tau hloov rau hom kev xaiv tsa qub vim tias nws qub lawm thiab nrhiav hloov nyuaj heev. Lub Xeev yeej tau npaj lub sij hawm los ntawm kev tso cai rau hom xaiv tsa tshiab no ua ntej yuav txog qhov kev xaiv tsa thaum Lub Peb Hlis 2020. Lub Nroog tau ua tsib lub rooj sib tham nrog cov neeg hauv zej zos txhawm rau kev tshawb nrhiav seb Lub Nroog Fresno puas yuav hloov los sis tsis hloov raws li txoj qauv cai VCA, qhov no yuav cuam tshuam txog kev yuav cov khoom siv. Saib raws li cov lus xam pom los ntawm cov rooj sib tham, kev sib txuas lus nrog tsib lub nroog uas twb hloov los siv txoj qauv cai VCA lawm, Feem Tuav Ntaub Ntawv ntawm Lub Xeev, thiab lwm cov nroog tab tom sib sab laj, Tus Tuav Ntaub Ntawv/Tus Saib Xyuas Kev Tso Npe Pov Npav Ntawm Lub Nroog Fresno, yawg Brandi Orth tau hais kom Pawg Thawj Coj Pab Tswv Yim uas Lub Nroog Fresno yuav hloov mus siv txoj qauv cai VCA yog feem los txiav txim. Pawg Thawj Coj Pab Tswv Yim tau pov npav pom zoo rau thaum Lub Peb Hlis 12, 2019 lawm tias yuav raug pib koj los siv rau qhov kev xaiv tsa Tus Thawj Kav Teb Chaws Zaum Xub Thawj rau thaum Lub Peb Hlis 2020. Lwm Lub Nroog hauv California uas tab

tom sib tham (ua ntej Lub Rau Hlis 2020) yog: Amador, El Dorado, Los Angeles, Mariposa, Orange, thiab Santa Clara.

Txoj qauv cai VCA ua rau txhua tus neeg pov npav muaj sij hawm ntau los pov npav rau lawv daim ntawv xaiv tsa. Cov neeg pov npav tuaj yeem xaiv pov npav rau ib ntawm Cov Chaw Pov Npav uas qhib rau txhua tus neeg pov npav tsawg kawg yog 93 teev los pov npav rau hauv lub sij hawm pov npav 11 hnuv rau ntawm Cov Chaw Pov Npav yog muab piv rau 13 teev (ib hnuv) raws li lub chaw pov npav ua qauv. Cov sij hawm teev tshaj no yog suav txog cov hnuv qab as thiv thiab cov hnuv so. Ntxiv rau qhov no, feem saib xyuas kev tso npe pov npav yuav qhia txhua Lub Chaw Pov Npav sib txawv ntawm ib lub chaw (Lub Chaw Xaiv Tsa) raws li lub chaw pov npav ua qauv.

Kev Xaiv Tsa Ntawm Lub Nroog Fresno yav dhau los yeej siv VAAC (Voter Accessibility Advisory Committee-Pawg Kws Pab Tswv Yim Rau Neeg Pov Npav) thiab LAAC (Language Accessibility Advisory Committee - Pawg Kws Pab Tswv Yim Txog Kev Txhais Lus). Txawm tias ob pawg kws pab tswv yim no yeej tau los sib tham ua ntej yuav coj Txoj Cai ntawm Tus Neeg Pov Npav Qhov Kev Xaiv los siv thiab cov neeg sawv cev tam ntawm ob pawg kws pab tswv yim no yeej tau mus koom cov rooj sib tham hauv tsib lub nroog rau thaum kev sib tham thawj zaug txog txoj cai VCA thaum Lub Peb Hlis 2019. Ntxiv rau qhov no, Txoj Cai ntawm Tus Neeg Pov Npav Qhov Kev Xaiv Pawg Kws Pab Tswv Yim (Voter's Choice Act Advisory Committee-VCAAC) tshiab nrog feem sawv cev los ntawm VAAC thiab LAAC yeej pib sib tham rau thaum Lub Peb Hlis 2019 lawm.

Cov lus xam pom los ntawm cov rooj sib tham ntawm cov zos no, pawg VAAC, LAAC, thiab VCAAC raug muab los sab laj thiab raug siv coj los tsim kho Qhov Kev Npaj Tswj Xyuas Kev Xaiv Tsa (Elections Administration Plan-EAP) no, yuav qhia tias Lub Nroog Fresno yuav siv txoj qauv cai VCA li cas, suav txog Qhov Kev Npaj Qhuab Qhia Rau Tus Neeg Pov Npav thiab Kev Nthuav Qhia kom mus raws li California Txoj Cai Kev Xaiv Tsa Tshooj 4005(a) et seg. Saib Cov Ntaub Ntawv Muab Tso Nrog Ua Ke A yog xav saib ua pov thawj rau ntawm tshooj cai no thiab qhov kev npaj.

Lub Nroog yuav npaj cov rooj sib tham txog kev qhuab qhia rau tus neeg pov npav uas xiam oob qhab thiab rau cov neeg uas tsis paub hais lus As Kiv. Yuav muab cov ntaub ntawv nthuav qhia rau ntawm ntau cov koom txoos hauv cov zej zog. Txhua tus neeg pov npav yuav tau txais ob tsab ntawv xa tuaj piav qhia tias txhua tus neeg pov npav tau txais ib daim ntawv xaiv tsa xa tuaj thiab muaj qhov kev xaiv rau pov npav rau. Yuav muab cov ntaub ntawv sib txuas lus tag nrho txhais ua lus Mev raws li tsoom fww Txoj Cai Kev Pov Npav ntawm xyoo 1965. Ntxiv rau qhov no, yuav muab cov kab ntawv xa tuaj thiab cov ntaub ntawv pov npav txhais ua ntau hom lus raws li California Txoj Cai Kev Xaiv Tsa xws li: Lus Punjabi, Lus Hmoob, Lus Suav, Lus Kaus Lim, Lus Cas Pus Cias, Lus Nyab Laj, thiab Lus Tagalog. Yuav muab phau ntawv qhia txog kev siv txoj qauv cai VCA rau cov chaw ua hauj lwm, yog li ntawd lawv thiaj tau siv cov ntaub ntawv no qhia rau lawv cov zej zog. Nrog rau cov lus xam pom los ntawm peb pawg kws pab tswv yim thiab yam raug muab los sab laj, Lub Nroog yuav txheeb xyuas cov chaw rau 50 lub chaw pov npav thiab 33 cov thawv tso cov ntawv xaiv tsa uas yuav raug siv rau qhov kev xaiv tsa thaum Lub Peb Hlis 2020. Tuaj yeem mus tau rau ntawm txhua lub chaw pov npav thiab muaj kev saib xyuas zoo rau sawd daws, xws li muaj cov ntawv xaiv tsa raws li xav tau, yog li ntawd cov neeg pov npav ntawm Lub Nroog Fresno thiaj li tuaj yeem mus pov npav rau ntawm lub chaw pov npav twg los tau. Kaum lub chaw pov npav yuav qhib ntev txog 11 hnuv thiab cov chaw pov npav seem ntawd yuav qhib ntev txog 4 hnuv, suav txog cov hnuv qab as thiv, cov hnuv

so thiab hnub xaiv tsa. Cov thawv tso cov ntawv xaiv tsa xa tuaj ntawd yuav qhib ntev txog 29 hnub ua ntej txog thaum xaiv tsa.

3. 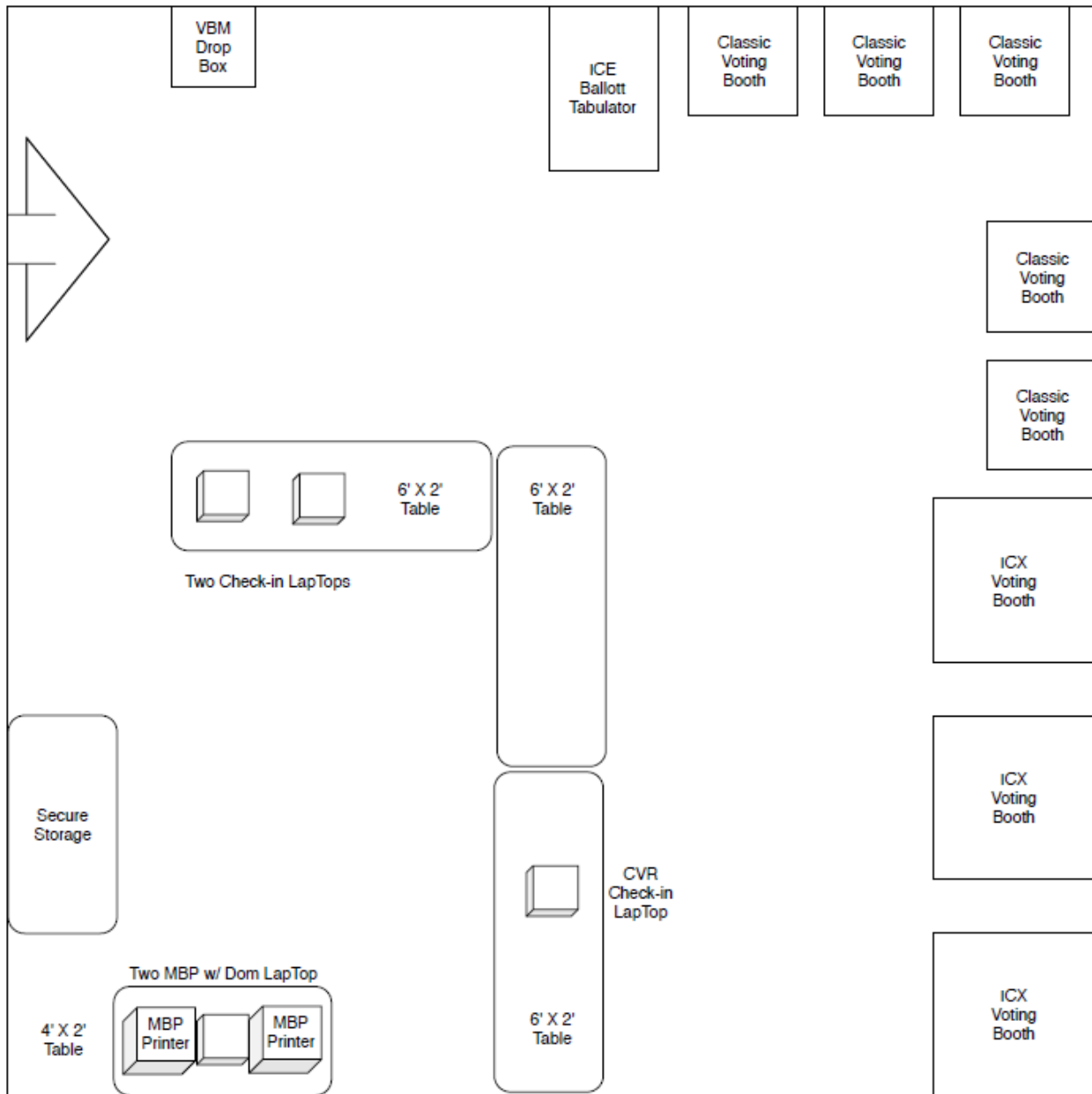

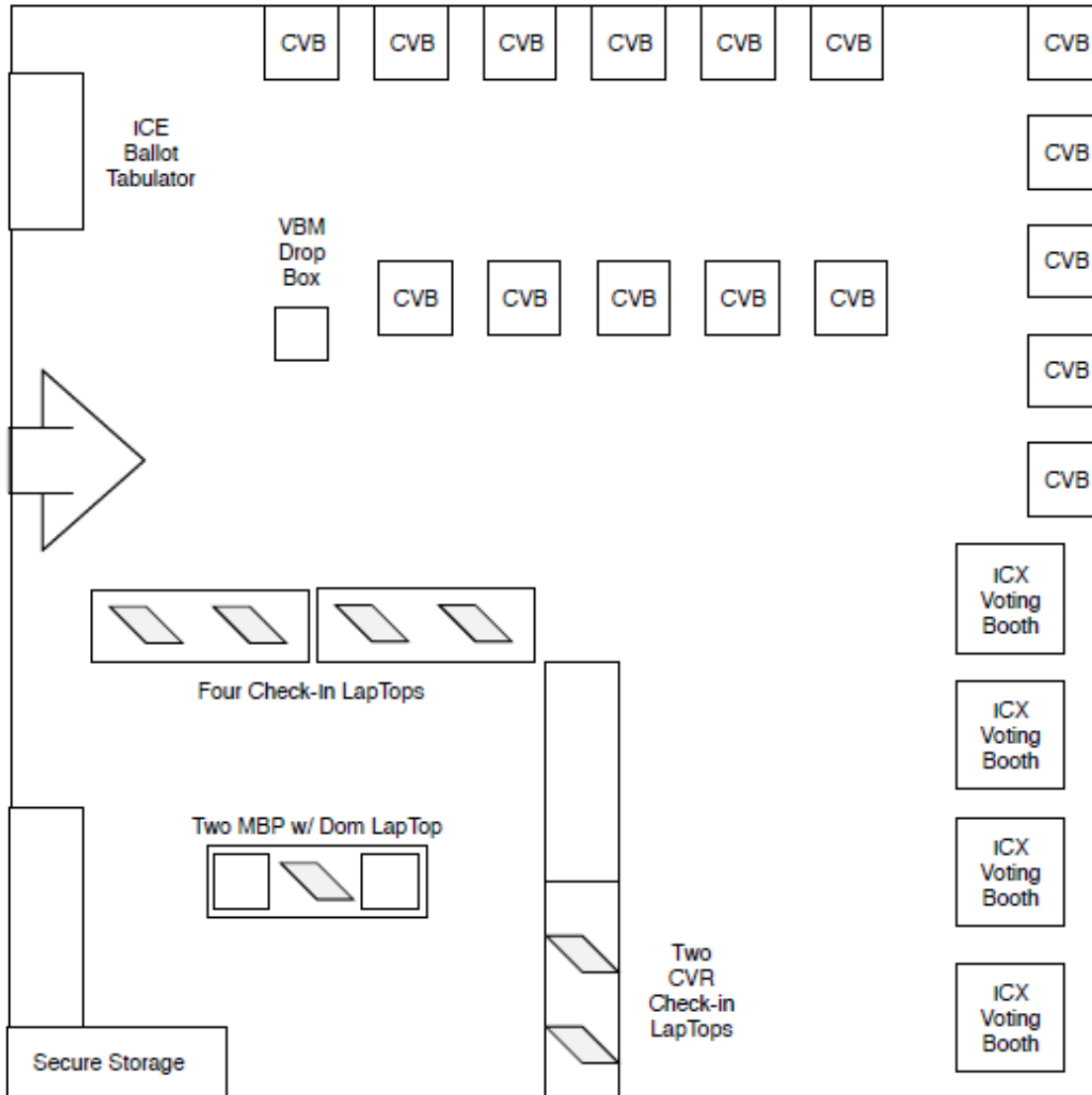

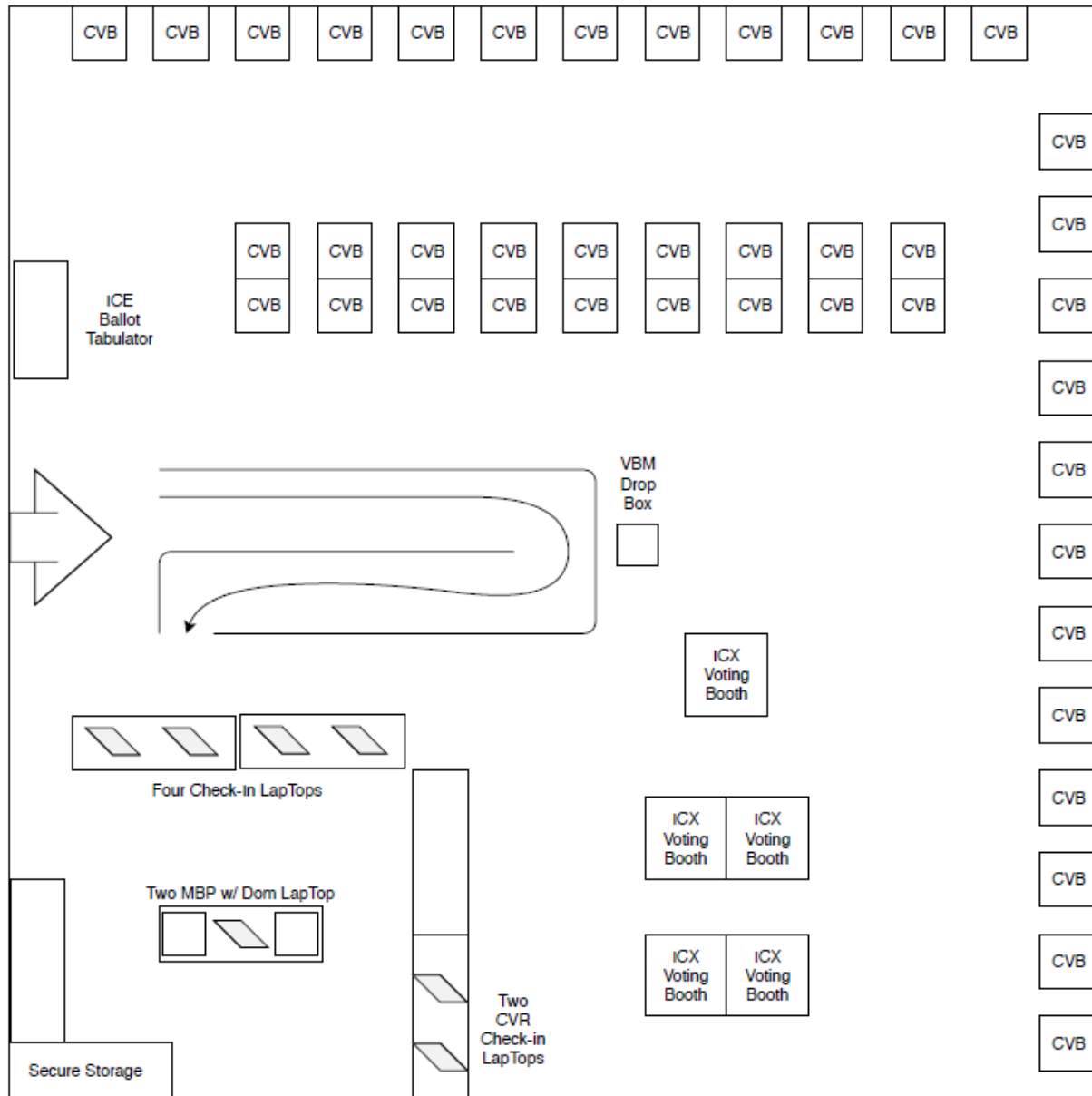
