GUIDELINES FOR DISPOSAL OF AGRICULTURAL TREATED WOOD WASTE AT AMERICAN AVENUE DISPOSAL SITE

The enclosed TWW Disposal Application must be submitted to: Fresno County Department of Public Works and Planning, Resources Division. The application may be submitted electronically to: emagana@fresnocountyca.gov. A hard copy of the application may be submitted to the Resources Division office at 2220 Tulare Street (6th Floor), Fresno CA 93721, Attention: Eyrin Magana. If you have questions related to the application or the American Avenue Disposal Site Acceptance Program (AADS TWW Program) you may contact the Resources Division office at (559) 600-4259.

Provided below is the step-by-step process to obtain the information required for the application. ***Please note that the AADS TWW Program only accepts agriculturally derived treated wood waste (TWW) (IE. grape stakes/orchard stakes and/or end posts).***

- 1) Treated Wood Waste(TWW) / EPA ID Number.
 - a) To obtain an ID number:
 1. Go to <http://www.dtsc.ca.gov>
 2. Click or hover over the link "Hazardous Waste"
 3. Click on the tab "Hazardous Waste EPA ID Numbers"
 4. Click on an option under "State EPA ID Number" that suits your business needs: "Permanent State EPA ID or Temporary State EPA ID".

5. Read the State ID Number Issuance Website information; provide your e-mail address. You will then receive an e-mail from epaid@dtsc.gov that will contain a link that will allow you to add your site data to the system to complete your application process.

6. **If you have any questions, please contact Department of Toxic Substances and Control (DTSC) at (800) 618-6942.**

Next, enter the name, address, contact person names, mailing address and telephone number of the generator. TWW/EPA ID Numbers beginning with CAC are temporary, 90-day numbers and expire at the end of this period. Any TWW loads brought to American Avenue Disposal Site after this 90-day period requires a new TWW/EPA ID Number.

2) Type of *Agricultural Treated Wood Waste* (i.e., Grape Stakes, End Posts, Orchard Stakes, etc.).

3) Jurisdiction of waste (Address or Cross Streets).

Once the County has approved your TWW Disposal Application, you will receive a TWW Disposal Authorization letter granting permission to dispose of the TWW at the American Avenue Disposal Site within five working days. The Disposal Authorization letter will provide direction on next steps. The next steps in the letter **MUST** be followed or the TWW will not be accepted at the American Avenue Disposal Site.
