



Dear Applicant:

Bounce Houses, water slides, or other similar activities are allowed in Fresno County Parks picnic areas. Your request for a commercial activity (bounce house, water slide, etc.) will be approved contingent upon the County receiving a completed Parks Special Event Permit (see attached), together with a valid Certificate of Liability Insurance. This insurance is generally available from the operator supplying you with the activity.

The Certificate of Insurance, in the amount of \$1,000,000, with a \$2,000,000 aggregate, **must name Fresno County as Certificate Holder and additional insured.** This certificate must be brought in, mailed or faxed to us along with the completed permit form. Additionally, the certificate must have your name on it, so we may identify it as coverage for your event. Because of the number of certificates received, we are unable to correlate unidentified certificates with specific events.

Please share this information with the commercial operator providing activities for your event. We must have the certificate on file at least **one week** prior to your event.

Remember –

In order for your Bounce House or other similar activity to be approved, you **must** bring in, mail or fax:

1. the completed Parks Special Event Permit
with
2. the valid Certificate of Liability Insurance
