The returns of the above-captioned mail-in ballot elections were tabulated and canvassed November 17 and 20, 2017, by the County Clerk/Registrar of Voters (“County Clerk”), 2221 Kern Street, Fresno, California.

FCERA is required under the Board of Retirement Election Procedures, adopted by the Board of Supervisors on December 8, 2015 (“Election Procedures”), to deliver and certify complete and accurate lists of all eligible voters for the Active Member Elections based on their respective categories of General Members and Safety Members, as of the date of their submission to the County Clerk (“Submission Date”). The Election Procedures state that ballots mailed by the County Clerk to members are based on such member voter data provided by FCERA.

On October 9, 2017, FCERA delivered to the County Clerk two lists of members whom FCERA determined to be eligible to vote for the Active Member Elections of the Board of Retirement trustees 2 & 3 (General Members), and 7 (Safety Members).

During the canvass of votes cast in the November 16, 2017 election for the above-captioned offices, the County Clerk discovered that FCERA included certain members both on the General Member voter list and on the Safety Member voter list, which resulted in each of those members receiving two ballots. Of those members who received both General Member ballots and Safety Member ballots, a total of 28 members timely returned both General Member ballots and Safety Member ballots to the County Clerk.

The County Clerk’s jurisdiction in the Board of Retirement elections only relates to the administration of the elections and canvass of votes. The County Clerk’s jurisdiction does not extend to the determination of the legal effect of FCERA’s actions referenced above.

The results of said canvass are final, and are attached, subject to the foregoing conditions.
