BBP training which meets Cal/OSHA's Bloodborne Pathogens Standard 8 CCR 5193 is required for persons who may be exposed to BBP while performing their routine work functions. This includes, but not limited to: tattoo artists, permanent cosmetics professionals, and body piercers. Additionally, State Body Art Regulations require that the training and training material must be specific to performing body art. BBP training contact time must meet a minimum of 2 hours. Training must be renewed annually. Records must be kept for a minimum of 3 years.
