We received your April 27, 2010 request for Training, Technical Assistance and Capacity Building funds, which is from the Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) Statewide Project. On behalf of the Mental Health Services Oversight and Accountability Commission (MHSOAC), we have determined that the request meets the requirements established by the Department of Mental Health (DMH) and the MHSOAC.

- FY 10-11 PEI Training, Technical Assistance & Capacity Building: \$151,300


